The Late Effects of Polio

In 1955, when the Salk and Sabin vaccines brought an end to the annual summer nightmare of polio epidemics, most Americans put thoughts of polio out of their minds. Once those who actually had polio regained maximum function through rigorous and extensive therapies, it was believed that the level of recovery would be permanent.

However, in recent years, many survivors have been reporting that their bodies are changing; and in many instances, their quality of life is being adversely affected. The symptoms most frequently described are increased fatigue, muscle weakness and pain, respiratory difficulties, and intolerance to cold. These problems range from unpleasant to severely debilitating.

Polio survivors pushed themselves and their doctors to learn what was happening. The result was the identification of late effects of polio - also called post polio sequelae or post polio syndrome.

Ohio Polio Network

In 1987, several local post polio support groups in Ohio began to meet together to exchange program plans, membership techniques and fund raising ideas. They soon realized they could work together to hold state-wide activities that each group could not sponsor by itself. This led to the formation of the Ohio Polio Network with polio survivors and interested professionals on its board under the sponsorship of the Ohio Easter Seal Society, Inc. In 1993, the Ohio Easter Seal Society's Board voted to combine with the Local Easter Seal Chapter in the Cleveland area and surrounding counties.

The Ohio Polio Network (OPN) became an independent organization on September 1, 1993. OPN is a non-profit & tax exempt organization under: IRS 501(c) 3 and Public Charity 901 (a)(2). Contributions are tax deductible.

OPN's activities include assistance with local support groups, promotion of research into the effects of post-poliomyelitis, collection and dissemination of information, education of individuals and concerned professionals, provision of a newsletter to members, organization and support of state conferences, help with referrals to knowledgeable professionals, and the solicitation of funds for the accomplishment of these services.

OPN is the Ohio contact for Post-Polio Health International (formerly GINI), an international network whose mission is to enhance the lives and independence of polio survivors and home mechanical ventilator users by promoting education, networking, and advocacy among these individuals and healthcare providers.



September 2023 - Polio Awareness Month in Ohio

Proclamation

by Governor Mike DeWine

WHEREAS, Before the Salk and Sabine Vaccine of the 1950's, the threat of Polio, the "Dread Disease", previously known as Infantile Paralysis, the pandemic of the day, was feared by every family, and,

WHEREAS, This "Dread Disease" spawned an equally fearful offspring, years after its initial attack, known as Post-Polio Syndrome or "The late Effects of Polio", to further debilitate many people who survived their initial bout of Polio, and,

WHEREAS, Polio is still a threat to people who have not been vaccinated, and Post-Polio Syndrome is still a threat to persons who have had Polio, and,

WHEREAS, There are an estimated 300,000 Paralytic Polio Survivors in the United States today, of whom as many as 75,000 or more experience the Late Effects of Polio, and,

WHEREAS, according to research, between 25% and 40% of Paralytic Polio survivors will fall victim to Post-Polio Syndrome, including all Polio Survivors residing in the State of Ohio, and,

WHEREAS, Conserving energy and limiting activities are the only defense against the fatigue, pain, muscle weakness, difficulty breathing, swallowing, depression, swelling of limbs, sensitivity to cold, joint and muscle pain, weight gain and atrophy brought about by "The Late Effects of Polio", and,

WHEREAS, The Ohio Polio Network, and the Post-Polio Support Groups around the State and surrounding area, are dedicated to meeting the needs of Polio Survivors, and

WHEREAS, September 1, 2023 will mark the 30th year since the Ohio Polio Network was established in 1993,

NOW THEREFORE, be it resolved that I, Mike DeWine, Governor of the Great State of Ohio, due hereby proclaim the Month of September, in the year 2023 as

Polio Awareness Month

in Ohio and encourage all its citizens to be more aware of the often debilitating effects of Post-Polio Syndrome, following the initial attack of Polio.

2023 Ohio Polio Network Bernice Krumhansl Advocacy Award

This award is presented to a polio survivor or other individual who is an outstanding advocate -- a person who has worked actively in support of improving the lives of polio survivors and people with other disability issues. Prior recipients are not eligible to be nominated. This award was originally established by the OPN Board in 1988. It was called the **People First/Disability Second Award**. It was later changed to the Bernice Krumhansl Advocacy Award in honor of Bernice Krumhansl's untiring efforts in working with polio survivors to help them maintain their quality of life.

Bernice worked for 34 years at St. Luke's Medical Center, retiring in 1986 as director of the physical therapy department. She specialized in working with polio patients. Bernice wrote many articles on a variety of subjects, including a textbook on physical therapy. She also traveled extensively on a lecture circuit. Her cousin, Bill Krumhansl, said it best: "She was special because she healed the old-fashioned way. She healed with her hands, with her heart, and with her head."
